This addendum will form part of the contract documents.

This Addendum 003 is issued to provide a clarification, update the specifications and to provide responses to questions from bidders.

**Clarification**

- .1 With reference to drawing SP-DR-001-Rev1, this contract will include dredging of only the "Area to Dredge – Disposal at Sea." This contract does not include dredging of the hatched "Area to Dredge – Upland Disposal."

**1.6 WASTE MANAGEMENT AND DISPOSAL**

- .1 Approximately 35,000m<sup>3</sup> of dredge material needs to be disposed of at the Point Grey - Ocean Disposal Site as approved with permit. Location of disposal site is outlined in tender drawings.
- .2 In-river disposal is not permitted.
- .3 The permit for disposal at the DAS site will be obtained by the owner.
- .4 The contractor is responsible for securing any permits and approvals for transit of materials to the DAS site at Point Grey, as specified in the contract documents.
- .5 Type of basin material in the vicinity of the general site area was investigated in 2014, and is primarily classified as Class B material:
  - .1 0.0 – 0.8m: silty sand and shells (grey), occasional gravel, loose to compact
  - .2 0.8 – 1.8m: silty medium to fine sand (grey), trace to some shells, compacted
  - .3 1.8 – 2.4m: some gravel dense with depth
- .6 This dredging area had been sampled and analysed in 2015. The analytical results indicated that, for some of the materials, Polycyclic Aromatic Hydrocarbons (PAH), metals and Polychlorinated Buphenyls (PCBs) are below Environmental Canada's Ocean Disposal Screening level. The remaining material is above Environmental Canada's Ocean Disposal Screening level and requires upland disposal.
- .7 The Contractor is responsible for transporting the dredge material to the disposal site. The transportation and handling of the dredge material must be compliant with, but not limited to safety and environmental requirements under all associated permits and approvals.
- .8 Metals, wood and recyclable materials, if any, removed during the dredging activities must be diverted appropriate recycling facilities.

**Responses to Questions from Bidders**

- Q1.** Under Section 35 20 23, Dredging, could you please explain Part 1, 1.2.11 under Measurement Procedures which states, "Removal of infilling material will not be measured for payment." What is infilling material?
- A1.** Infilling material is defined as sediment that is sloughing in or depositing during dredging operations. The Owner will not make payment for materials from outside of designated dredge area. It is the responsibility of the contractor to insure side slopes are sufficient to not allow materials from other areas to enter the dredged area.
