This amendment is raised to answer questions from potential bidders.

Q1. The specifications regarding the ballistic covering material has contradicting information.

The solicitation states 92 g/m² equals to 1.9oz/yd². At this weight there is not heatsealable material available by the industry.

We spoke with a material supplier and they explained that there is not a material in the industry that meets these requirements.

A1. DND will increase the maximum weight requirement to 125 g/m². Breaking strength in the warp direction minimum will be relaxed to 500 N. No change is made to the tearing strength requirement.

Q2. Annex C-1

When reviewing the table for Collar Panel Component Dimensions, page C1-30/54 "B" Collar width of 2.375 inches and the table for Collar Protector Dimension's page C1-33/54 "M" Collar width of 2.375 inches. There is no easement given provided in the table for the collar protector width to allow the collar panel to fit. When comparing the two tables for the length of Collar Protector to the length of the Collar Panel there is an easement of .5 inches given. This easement in the length of the collar protector is to allow the collar panel to fit in. There also needs to be an easement for the width.

The patterns supplied allow for an easement of .5 inches in the width. Suggest that the Collar Protector Dimensions table have "M" width of collar at center be changed from 2.375 to 2.875 to allow for the easement and to be compliant to the tables.

A2. Collar Ballistic panel width edge to edge: 2.375" +/- tolerance in chart

Collar protector cover finished width edge to edge: 2.875" +/- tolerance in chart

These measurements reflect the pattern pieces as provided +/- .03"

All other Terms and Conditions remain the same
