This amendment has been raised to respond to the following questions and to add the Bidder's Site Meeting Attendance Sheet:

Question 1: Can concrete be crushed and disposed of on-site or does it need to be removed from site and disposed of elsewhere?

Answer 1: This answer can be found within Section 02 41 16 3.2.

Question 2: Do trees and shrubs within yard site get removed?

Answer 2: Minimum disturbance of site is to be achieved if possible. Leave all shrubbery and trees in place if disturbance is not necessary. As per Section 01 35 43, 1.12.3.

Question 3: Is there a natural gas line to the site that needs to be decommissioned?

Answer 3: No natural gas line is present on the site. A propane tank formerly was located north of the site. Lines associated with this propane tank will need to be removed as part of the contract.

Question 4: Are 'telephone' poles on west side of the yard to be removed?

Answer 4: No, these stay on site.

Question 5: Can aboveground storage tanks be recertified?

Answer 5: No, removal of AST is to be completed as per the Aboveground Storage Tank Removal Specification 02 65 01.

Question 6: Is perimeter fencing to be removed?

Answer 6: No, perimeter fencing is to remain.

Question 7: Can topsoil be imported?

Answer 7: Refer to specification 32 91 19.13 Topsoil Placement and Grading for topsoil requirements.

Question 8: Has hazardous materials assessment been completed?

Answer 8: Yes. Refer to hazardous materials specifications within supplied documentation for specific requirements.

Question 9: Is environmental monitoring required as part of the contract for removal of the aboveground storage tanks, septic tanks and hazardous materials removal?

Answer 9: These items are to be decommissioned/removed/disposed of as per the Specifications. Specific requirements for each of these items can be found within the supplied documentation. Mitigation Measures and Report Form will also need to be provided to by the contractor upon closure of project (also within supplied documentation).

Question 10: Can contractors return to site for an additional site visit prior to tender closure?

Answer 10: No, as we don't have funds, time, resources to attend another site visit and contractors cannot access the site without a representative.

All other terms and conditions of the Invitation to Tender remain unchanged.
