Questions

1. Platform,

The platform is doable in a portable modular insulation system, it will be expensive to create the R - value 10 to 20. If I get a R-value of 20 with 4 inch of insulation is it GTG or do they still require a base of 8 - 12 inch of insulation. I can give the client a insulation base of R-value of 50 with a depth of 10 inch base.

We agree with this observation.

More important for us is to have the R- value asked. A 4-inch thickness is sufficient.

The mix between the thickness, the nature and the morphology of the floor should give a good mechanical strength and a good thermal and water insulation.

2. Divider.

We can make a wall divider with a different material than the external fabric, It is the same fabric like the liner, it would be easier to install and lighter than the external fabric.

We want that the divider is made of a material more resistant than the liner. Part of the tent will be used as a warehouse and we wants to ensure that access is limited.

3. 4 ft extension

the 4ft extension is doable, but those the client require the same width and height. It is a lot of material to just make an extra 4 foot extension lower cost. Why not just add the 4 ft extension into the shelter on each end for an addition 8 ft extra. A 4 ft porch would be easier to install then the same width and height. Would they require extra light and heat?

Tents extensions and accessories for those not subject to the bid. However the tents should have the option to be lengthened.
