Question 1:

An extension to the closing date for responses to RFI #4 is requested from December 23, 2015 to January 20, 2016 due to the significant effort industry requires to analyze the large amount of information (i.e. the draft request for proposals attached to the RFI) to provide comprehensive feedback to Canada.

Answer 1:

Thank you to all GCRSS industry engagement participants for your interest and participation in the industry engagement activities of the Government of Canada Relocation Support Services (GCRSS) procurement initiative. Your feedback has contributed towards the refinement of GCRSS requirements in a competitive solicitation environment.

This Request for Information (RFI) #4 is a continuation of industry engagement activities that began in 2013, and provides further refinement of the requirements to be finalized in the Request For Proposals (RFPs) scheduled to be issued in mid-January, 2016 as described in the RFI.

An extension to the RFI closing date is not granted as Canada requires time to review all responses received prior to finalizing the RFPs. Note that, if an RFI response is received after the closing date, Canada may, in its discretion review the response, as described in section 6 - Treatment of Responses subsection (a) of the RFI document.
