AMENDMENT 001

The purpose of this amendment is to:

Part A) Respond to bidder's questions:

Question 1: In Annex "A" Specifications – Parks Canada, Item 1.2 Manual tilt, could you please confirm if the tag-a-long trailer is manual or if the trailer can be an air tilt?

Answer 1: Trailer can be either manual or air tilt. Ramps must be air tilt. Please see revision to Item 1.2.

Question 2: In Annex "A" Specifications – Parks Canada, Item 1.10 Lockable tool box, could you please confirm if a tool box in the triangle is sufficient or does the tool box have to be on the side of the trailer? Is a metal tool box sufficient or does the tool box need to be aluminum?

Answer 2: Tool box must be located within the triangle section of the hitch. Tool box must be fabricated using bare metal but must be painted as per Item 1.19. Please see revision to Item 1.10.

Question 3: In Annex "A" Specifications – Parks Canada, Item 1.13 tie downs, could you please confirm if the requirement is for twelve (12) tie downs per side or twelve (12) tie downs in total (six (6) tie downs per side)?

Answer 3: The tie down requirement is for six (6) tie downs per side (Twelve (12) tie downs in total). Please see revision to Item 1.13.

Question 4: Could you please confirm if the trailer must have an air suspension or a spring suspension?

Answer 4: Both Air and Spring Suspension are acceptable. Please see Item 1.21.

Question 5: Could you please confirm if the axle spreads must be 60 inches or 72 inches?

Answer 5: A trailer with a GVWR of 67,500lbs and a payload capacity of 55,000lbs would typically be of a tri-axle configuration having a 54" c/c axle spread/spacing. However if the supplier can provide a trailer of a different configuration with a 60" or 72" axle spread it would be acceptable as long as the trailer meets the 67,500lbs GVWR and 55,000lbs payload capacity requirement.

Question 6: Could you please confirm if the beaver tail can be made of wood or if they must be made of angle iron?

Answer 6: The beaver tail or sloped portion of the trailer must be constructed from the same material as. Please see Item 1.22.

Question 7: Could you please confirm the number of ramps required and width of the required ramp(s)?

Answer 7: Two (2) ramps are required, one (1) for the left wheel/track to travel on and one (1) for the right wheel/track to travel on. Each ramp is to be a minimum 42" wide and 5' long. Please see Item 1.23.

Question 8: Could you please confirm if the ramps can be made of wood or if they must be made of angle iron? And length and width?

Answer 8: Please see responses to Questions 6 & 7.

Question 9: In Annex "A" Specification – Parks Canada, Item 1.18 Safety Chains or Cable, could you please how many and what the safety chains are required to secure (truck, load or both)?

Answer 9: There are two (2) safety chains/cables required. They are used to secure the trailer to the truck in the event of the trailer breaking free from the truck hitch. Please see revision for Item 1.18.

Question 10: Could you please confirm if the trailer is to be delivered to the park or can the trailer be delivered to the port?

Answer 10: Trailer must be delivered to Terra Nova National Park.

Question 11: Could you please confirm if air ramps are acceptable or are hydraulic ramps with a hydraulics unit required?

Answer 11: Ramps must be air operated. Please see Item 1.23.
