Overview;

The following is the minimum Government of Canada requirements for one (1) surface grinder to be used in the machine shop at Department of National Defence (DND) Fleet Maintenance Facility CAPE BRETON (FMF CB).

Item	Minimum Mandatory Requirements	Comments	Bid Ref Page #	Pass/Fail
UNIT REQUIREMENTS				
1.1	Unit must be electrically certified by an approved Canadian agency. Acceptable agencies are Canadian Standards Association (CSA), Underwriters Laboratories Canada (ULc), or other approved Canadian electrical inspection agencies. Electrical certification must be completed prior to delivery.			
UNIT REQUIREMENTS				
1.2	Unit must be a surface grinder.			
1.3	Unit must have individual handwheels/levers/controls for fine manual positioning of each axis (i.e. longitudinal, crossfeed, up/downfeed).			
1.4	Unit must have a spindle with a power rating of 10 HP, at a minimum.			
1.5	Unit must have a table with the following features, at a minimum:			
1.5.1	Hydraulic feed with power rating of 5 HP			
1.5.2	Table Working Surface Capacity: 23" x 59"			
1.5.3	Maximum Table Load: 2500 lbs			
1.5.4	Electromagnetic chuck that covers the table's entire working surface capacity			
1.6	Unit must have the following travels limits, at a minimum:			
1.6.1	Longitudinal Table Travel: 59"			
1.6.2	Cross Travel: 23"			
1.7	Unit must have a maximum distance from spindle center to table surface of 22", at a minimum.			
1.8	Unit must have powered longitudinal table speeds within the range of 24 FPM to 80 FPM, at a minimum.			
1.9	Unit must be able to achieve automatic crossfeed per stroke within the range of 0.02" to 0.40", at a minimum.			
1.10	Unit must be able to achieve incremental downfeed within the range of 0.0002" to 0.0016", at minimum.

1.14	Unit must have a coolant system. Coolant system must have a tank, and a filtration/separation system for removing metal particulate from the coolant.			
1.15	Unit must have ‘V and flat’ (plane and prismatic) turcite tableways.			
1.16	Unit must have ‘double-V’ (double prismatic) turcite crossways.			
1.17	Unit must come with a 2-axis digital readout.
