REQUIREMENT

Part 1 General

1.1 SUMMARY

1. This Section specifies the materials and construction for new fuel-oil storage tanks.
2. These tanks will be incorporated into a functioning fuel supply system that is currently under design. These tanks will provide primary bulk fuel storage for a multiple emergency generator installation.
3. The purchase and order of this equipment shall be placed by the Canadian Coast Guard, Marine & Civil Infrastructure Division.
4. The supplier of the tanks under this specification section will be responsible for all shop drawings, product manufacturing, certifications and warranties, and delivery.
5. The installation of the tanks will be completed under a separate installation contract.

1.3 SUBMITTALS

1. Shop drawings to detail and indicate the following as applicable to project requirements. Submit manufacturer's product data to supplement shop drawings.

1. Size, materials and locations of ladders, lifting lugs.
2. Tanks capacity.
3. Total weight and base plate loads.
4. Size and location of fittings.
5. Decals, type, size and location.
6. Accessories: provide details and manufacturer's product data.
7. Finishes.
8. Piping, valves and fittings: type, materials, sizes, piping connection details.
9. Anchors: seismic criteria, description, material, size and locations.

2. Certificates: Shop drawings must be signed and sealed by a Professional Engineer registered in the Province of British Columbia for seismic restraints (anchoring).

3. Instructions: submit manufacturer's installation instructions.

4. Closeout submittals: submit maintenance and engineering data for tank appurtenances and leakage detection system for incorporation into Operations and Maintenance Manual.

Part 2 Products

2.1 ABOVE GROUND FUEL OIL STORAGE TANKS (DOUBLE WALL)

1. Tank Construction:

1. Horizontal cylindrical double-walled (secondary containment) fabricated, certified and labeled to ULC S601 for flammable and combustible fluids.

2. Material: low carbon steel.

3. Exterior coating: One (1) shop primer coat applied.

4. Fittings:

1. 1 – 50 mm fill line opening, connected to fill/spill box.
2. 1 - 50 mm primary tank vent opening c/w vent pipe with 180o close bend.
3. 1 - 100 mm primary tank emergency vent opening c/w cap.
4. 1 - Interstitial vacuum tapping for emergency vent c/w tamper guard, vacuum gauge.
5. 1 - 50 mm tapping for suction
6. 1 - 50 mm tapping for return
7. 3 - 50 mm diameter spare tapping (threaded and plugged)
8. 3 - 100 mm diameter spare tapping (threaded and plugged)

5. Vacuum applied to interstitial space.

2. Tank Support:

1. Two steel support saddles welded to tank, drilled for hold-down anchor bolts (seismic restraint).
2. Seismic restraint design must include details for epoxy embedment using Hilti HY-100 epoxy and 3/4" stainless steel (A193) threadrod anchors. Shop drawing must display shear and uplift forces for each anchor point.
3. Seismic restraint must be designed for the following criteria:
 1. Class A
 2. Min $S_a(0.2) = 1.1$
 3. Min $PGA = 0.53$
 4. Importance Factor (IE) = 1.3

3. Accessories:

1. Access stairs/platform complete with galvanized grip treads for filling and inspection of tanks.
 2. Lockable fill/spill box fabricated, complete with 100mm locking cap and collar, capped sounding port, and drain back to tank valve.
 3. Vacuum gauge (tank mounted).
 4. Dipstick and gauge chart. Dipstick to be tank mounted in lockable enclosure.
 5. Lifting lugs.
 6. Grounding lug.
4. Capacity: 5,000 L **[Must be equal to or greater than defined capacity.]**
