Item 3 – Onsite Work Technical Communication

The Bidders must ensure to provide technical communication services in French on the work site, through the mobilization of a key employee at the site, such as; foreman, project leader or project manager.

Item 4 – Section 1.15 of the specification; Familiarization

Eliminate the following paragraph:

All personnel working on the Sorel Canadian Coast Guard base must take a familiarization session and sign form 10.A.7. There will be two familiarization sessions. The first session will be held on the day of the meeting when construction begins, and the second will take place two weeks later. Familiarization sessions will be led by an employee of the Canadian Coast Guard. Each session will last 2 hours.

And replace by:

All personnel working on the Sorel Canadian Coast Guard base must take a familiarization session and sign form 10.A.7 before beginning any work on the CCG base. Familiarization sessions will be held every Monday. There will be only one familiarization session per week. Familiarization sessions will be led by an employee of the Canadian Coast Guard. Each session will last approximately 2 hours.

The Contractor must pay close attention at the starboard side transmission which present discoloration mark normally associated with overheating. Any reparation will be negotiated as an extra on a 1379 form.

Also, the Contractor must investigate a cooling liquid leak on the exhaust collector of the starboard side engine. Any reparation will be negotiated as an extra on a 1379 form.

Item 7 – Section 5.13.1 Generator Engine (Maintenance)

At item 5.13.1.3 of the specification, add the following text:

The Contractor must do the 4 and 12 months maintenance recommended by Perkins. Please note that the oil and filter change are completed and are not required.
