**Amendment No. 001**

This amendment is being raised to provide responses to Requests for Clarification.

**Responses to Requests for Clarification**

- Q1. We have security clearance that was done by PWGSC and the expiry dates are 2021, are we to get security clearance again?
- R1. Further to Supplementary Instructions 3 Security Requirements, Proponents are recommended to obtain, or hold, Facility Security Clearance (FSC) at the RELIABILITY level issued by the Canadian Industrial Security Directorate (CISD) for both the firm and their personnel.
- Q2. In Section 3.2.3 Past Experience of the Submission Requirements and Evaluation, 2 a) asks for a "brief description of a maximum of five (5) significant projects completed within the last seven (7) years". Does this statement indicate that all projects submitted for this section must be completed in their entirety, or can projects that are ongoing but substantially completed (or in construction) be submitted as well as part of the five projects?
- R2. The selected five projects should be completed, meaning the construction should be finished and the building ready for its intended use.
- Q3. For Section 3.2.4 Senior Personnel Expertise and Experience and Section 3.2.5. Project Personnel Expertise and Experience, can you please clarify what the difference is between these two classifications?
- R3. Senior Personnel are expected to demonstrate a senior level of experience and to exercise a supervisory role on the projects. Project Personnel are intended to be the day-to-day personnel assigned to the projects under this Standing Offer.
- Q4. For Section 3.2.4 Senior Personnel Expertise and Experience and Section 3.2.5. Project Personnel Expertise and Experience, can Senior Personnel also be considered as Project Personnel, or is the intent for firms to put forward different individuals with less experience than a "senior" resource might have?
- R4. Senior Personnel can also be considered Project Personnel if they are intended to be the day-to-day personnel assigned to the projects under this Standing Offer. The Consultant should put together the most representative and suitable team that is expected to work on the projects resulting from this Standing Offer.

- Q5. For Section 3.2.4 Senior Personnel Expertise and Experience and Section 3.2.5. Project Personnel Expertise and Experience, does the distinction of these two classifications correlate to the people whose c.v.'s are in the proposal's "Category of Personnel" on the pricing forms – ie. Is it required that Senior people included in the proposal have a financial category of Partners or Senior, while Project Personnel must fall into the other financial categories?
- R5. It is expected that the individuals identified as Senior Personnel would also be found in the Partner or Senior categories of the fee proposal. The individuals identified under Project Personnel should be those who will work on a day-to-day basis on the projects, and should be included in the related category of the fee proposal that is most appropriate.

All other terms and conditions of the solicitation remain the same.
