Additional Questions received to December 31, 2015

1. *Is locating and exposing the existing forcemain part of this contract?*

An alignment for the existing forcemain will be provided in digital format for layout by the Contractor. This alignment may be accessed by the trail that has been recently cleared along the general forcemain route.

The Contractor is to locate and expose the forcemain at roughly 100m intervals. These locations are to be surveyed as part of the Record Survey and are to include pipe and ground elevations. All excavated holes to be backfilled with native material following the final survey. The Contractor is to allow for locating the forcemain within 4m of the provided alignment.

2. *Does the existing forcemain have to be centered on the proposed 4m ROW?*

While centering the pipe is preferred, allowances will be made as dictated by existing conditions. This will be examined on a case by case basis. In all cases, the pipe will have to be within the cleared ROW.

3. *Are any repairs to the forcemain to be included in this contract?*

Contractors to allow for the potential repair/replacement of up to 30m of existing forcemain at one location. This location is where the forcemain is exposed approximately 20m NE of Sandhill Creek. Photos of the location is attached for reference. Supply and installation of all required parts, fittings, and material are to be included. Depth of bury to ensure no high spot in pipe is created.

As long as the integrity of the pipe is maintained, the alignment and elevations of the existing pipe may be adjusted and the pipe buried in place.
