**AMENDMENT 004****Questions and Answers:**

Q1. Please provide the number of days to assume for laboratory turn-around time in determining the level of contamination for the excavated and screened material?

A1. The excavated and screened material has already been characterized, so no laboratory turnaround time would apply in managing this material.

Q2. Section 01 35 43 – Environmental Procedures Part 1.14.3

The Departmental Representative will review all sampling results and will approve the disposal option based on the level of contamination found. All contaminated soils shall be disposed of as per the BC Contaminated Sites Regulation. The Contractor shall provide documented proof of proper disposal of contaminated soils to the Departmental Representative. Soils that are not contaminated will be transported and disposed of at the Contractor's disposal site, at no additional cost to the contract. The additional costs involved with the disposal of contaminated soils, which are over and above the included price of non-contaminated soils disposal, will be paid as an extra to the contract.

Can PWGSC provide a line item amount in tonnes to assume for disposal of non-contaminated material? Or remove this requirement from the soil management section?

A2. The highlighted section of the Section 01 35 43, 1.14.3 is being removed from the specification.

Q3. The additional costs involved with the disposal of contaminated soils, which are over and above the included price of non-contaminated soils disposal, will be paid as an extra to the contract. Can clarification be provided for the above statement?

A3. Statement removed from the specification.

Q4. Please confirm exceedance standards for disposal of IL+ soil under line item 6 are based on soil relocation standards and receiving site characteristics in accordance with BC CSR and not based on source site site-specific standards.

A4. The soil volume designated as IL+ in Line Item #6 consists of soils characterized as containing concentrations of metals contamination in excess of BC CSR Industrial Land Standards applicable to the Col-15 Site. The following site specific factors were considered as applicable to the Site:

- Intake of contaminated soil
- Toxicity to Soil Invertebrates and Plants
- Groundwater Flow to Surface Water Used by Marine and/or Estuarine Aquatic Life

Soils in Line Item #6 are also greater than Schedule 7 Column II Standards.

Q5. To avoid damaging the wooden section of the jetty can the boat ramp be utilized for delivery and removal of heavy equipment to and from the site?

A5. No, the boat ramp will not be used to deliver and remove equipment. Equipment brought to the site will require pre-approval but it's expected the necessary equipment will be allowed on the jetty.

All other terms and conditions remain unchanged.
