## 1. SPECIFICATIONS

### 1.1 Section 26 50 00, Clause 2.1.1 should read:

" **Indoor** solid state lighting rated correlated colour temperature (CCT) shall be with four (4) MacAdam ellipses of the specified CCT in the luminaire schedule. Colour consistency between lamps in the same **interior** fixture type shall be within four (4) MacAdam ellipses of the rated CCT. **Exterior** solid state lighting rated correlated colour temperature (CCT) shall be with **seven (7)** MacAdam ellipses of the specified CCT in the luminaire schedule. Colour consistency between lamps in the same **exterior** fixture type shall be within **seven (7)** MacAdam ellipses of the rated CCT. "

### 1.2 Section 26 24 16, add clause 3.1.5:

" .5 Where replacement panelboard interiors for retrofit installations exceed the depth of the existing flush-mounted panel enclosure, a suitable steel extension shall be fabricated and painted to match the existing enclosure and replacement panel cover assembly. The extension shall in no case extend more than 50mm beyond the existing panel closure. Where this condition occurs for existing surface mounted panelboards, the existing panel enclosure shall be replaced with new and all existing wiring/conduits terminated to new enclosure."
