This amendment is raised to:

A) Answer the following questions raised by the industry:

Q1: On the tender notice, metal towers are specified. Would Laminate towers be acceptable?

A1: No, metal is required.

Q2: Presently the height requirement is 50-51" which is very specific to one or two manufacturers. Is it possible to have the height at 54" H as that is a standard with a number of manufacturers?

A2: No, the workstations have all been ordered and the height of the panels is at 51". We do not want the cabinets to exceed that height.

B) Modify the Basis of Payment as follows:
