QUESTIONS AND ANSWERS

Q1. With respect to Amendment 1 of solicitation #21120-158459/B, could the Crown please clarify if the current RFP is a set-aside for aboriginal business? The RFP documents for solicitation #21120-158459/B do not state it is a set-aside, but QA 1 and 2 of Amendment 1 give contradictory statements. Please clarify.

A1. No, as per the RFP #21120-158459/B and Amendment 002, this RFP is not a set-aside for aboriginal businesses, but is only open to TBIPS Supply Arrangement Holders who qualify under Tier 2 for services in National Capital Region under the EN578-055605 series of SAs for the categories under the three Workstreams listed in the RFP.
