**B) Questions & Answers**

**Q1:** On page 15 it states 2.2 Activity Bus is a min seating of 35 with or without washroom and with air conditioning. We have a mini coach that is 33 seats, a/c and washroom. Would this be ok to service under this category?

**A1: No. Seating requirement is a minimum of 35.**

**Q2:** Section 5 of Annex A states "5. CALL-UP RESPONSE REQUIREMENTS

Vehicles may be required on an immediate basis and/or extremely short notice. Consequently, the Offeror must have sufficient vehicles to ensure rental requests are actioned within four (4) hours of receipt".

Does this mean we have no right to refuse work if we get a call from DND? We may be sold out or not have any vehicles available. Please advise.

**A2: We sometimes have a last minute emergency and expect the offeror to provide required services on short notice. This type of situation does not happen often and will be avoided as best as possible.**

**Q3:** Can you give us an idea of the average distance the coaches will travel when they are called up?

**A3: Unknown as requirements vary.**

**Q4:** Can you give us an idea of the length of day?

**A4: Unknown as requirements vary.**

**Q5:** Should Annex H – Certifications be included with the Technical Offer?

**A5:** Yes, please include it with the Technical Offer.
