Amendment No. 01 is raised to modify solicitation W0134-16R010 to address questions from industry as follows:

Question 1: Under the Mandatory Technical Criteria, there is a specification:

1.4 “spindle bore diameter of 2.750” minimum”

In our industry, there are 2 different specifications that this could apply to and many times there is some confusion so I wanted to clarify this with you.

Spec #1 – this could refer to the actual spindle bore of the lathe. The spindle bore is defined as the bore size of the spindle not including the chuck drawbar.

Spec #2 – this could also refer to the bore of the chuck drawtube – typically called the “maximum bar size” that can pass through the chuck draw tube.

As an example, you can have a lathe with a spindle bore of 3.5” with a “bar size” of 2”.

What I wanted to know is does this specification mean that the expectation would be the spindle bore is 2.75” or the bar size required to pass through the draw tube of the chuck is 2.75?

Answer 1: The minimum size of both. We require a minimum diameter of 2.750” bar stock to fit through both the chuck and spindle together
