QUESTION AND ANSWER – SERIES II

- Question 1: Projects of similar scope have taken a year to draft and previous study documents (only provided after contract award) cannot be used to expedite this study. Would the Crown explain how it expects this study to be completed in 30 days or less?

- **Question 2**: Will the Crown consider amending the expected completion dates to receiving a Draft document prior to 31 March and the completion of the study by April or May 2016?

THIS AMENDMENT IS RAISED TO CHANGE THE PERIOD OF CONTRACT, THE STATEMENT OF WORK, THE FINANCIAL PROPOSAL AND THE METHOD OF PAYMENT. THE REVISIONS ARE AS FOLLOWS:

1) At 6.4.1, Period of Contract, DELETE in its entirety and INSERT the following:

"The period of the Contract is from date of Contract Award to May 15, 2016 inclusive."

2) At Annex "A", Statement of Work, section 5.1 (Draft Report and Final Report), DELETE in its entirety and INSERT the following:

"5.1 Draft Report and Final Report - The contractor must prepare and submit a detailed report on findings and recommendations from the information collected in paragraphs 4.1 to 4.7.

Draft report: To be completed by March 31, 2016

Final report: To be completed by May 15, 2016

The reports must be submitted in the following formats:

- one hard copy; and
- one electronic copy in MS Word."

3) At Annex "B", Financial Proposal, section 1.0 Professional Fees, DELETE in its entirety and INSERT the following:

- a) an accurate and complete claim for payment and any other document required by the Contract have been submitted in accordance with the invoicing instructions provided in the Contract;
- b) all work associated with the milestone and as applicable any deliverable required has been completed and accepted by Canada."
