Amendment 007 has been raised to answer the following questions and revise the RFP as follows:

PART A:

Q1. We are requesting that the above specification be changed due to the fact that other federal government departments have set up national country-wide AED programs for their departments and didn't require the AEDs to be bilingual.

-The option to be able to modify the language during use can create both delays of treatment to the patient (every second counts), and also the possibility of errors/mistake.

A1. We concur with the bidders; the option to modify the language during use may create both delays of treatment to the patient and the possibility of errors/mistakes. As result we would like to amend Annex B to revert back to the original request to provide English or French units.

Shipping, training, manuals, software updates and preventative maintenance inspections included.

2. Delete: Page 6 of 25, Part 1 - GENERAL INFORMATION - 1.1.1 -- Optional Requirements

The Contractor grants to Canada the irrevocable option to purchase up to six English AEDs and up to two French AEDs under the same terms and conditions and at the prices stated in the contract. The option may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the option prior to March 31, 2018 by sending a written notice to the Contractor.

3. Delete: Page 13 of 25, Part 6 – Resulting Contract Clauses, Article 6.2.1, Optional Requirement

The Contractor grants to Canada the irrevocable option to purchase up to six (6) English AEDs and up to two (2) French AEDs under the same terms and conditions and at the prices stated in the contract. The option may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

4. Delete: Page 16 of 25, Article 6.6.2 Optional Requirement
