I.1 ADDENDUM FORM

I.2 CHANGES TO THE PROJECT MANUAL

- .1 SECTION 23 81 26 – Split-Type Room Air Conditioners
 - .1 **Clarification** Item 2.3 Outdoor Condensing Units - There is a concrete floor in the shaft at the 3rd Floor level, and a metal grate at the 4th Floor level; there is no access to the shaft at Penthouse level. Include allowance for opening an access hole in the drywall shaft to install refrigerant piping, and for patching the shaft after installation.
- .2 SECTION 28 23 00 – Video Surveillance
 - .1 **Delete** Section 28 23 00 entirely.

 - .1 **Delete** video surveillance camera designated as V-01 and V-02 including all cabling. Conduit is to remain.
