## **AMENDMENT 002**

This Amendment 002 has been raised to post questions and answers for the solicitation:

Q1) Can PWGSC please confirm the attendee's to the tender site meeting on January 11, 2016?

A1) A list has been posted with Amendment 001.

Q2 Can PWGSC confirm if the contractor is responsible for carrying the cost of the Building Material Survey?

A2) The Contractor must complete a hazardous building materials survey of the shed prior to any building demolition work. Should material resembling spray or trowel applied asbestos, paint potentially containing lead or other hazardous building materials be encountered in course of demolition, stop work, take preventative measures, and notify the Departmental Representative immediately. Do not proceed until written instructions have been received.

Amendment to Unit Price Table Line Item 12

Line item to include costs associated with the hazardous material survey. Costs for the demolition, removal, and off-site disposal of wooden shed and debris contained within are to assume no hazardous materials.

Q3) As site work cannot commence until the site is cleared of the various stockpiles can an extension of 2 days to the tender due date be provided to all tenderers?

A3) An extension will not be granted. The stockpiles observed during the bidder's meeting will be removed by the start of work.

All other terms and conditions remain unchanged.
