### **Amendment 1**

This amendment is being raised to address questions asked by bidder(s).

Question 1: What are you trying to accomplish in the tanks? I ask this because there are many customers growing fish in containers and not using round fibreglass container.

Response: Tubs, as specified, will be used for short and long term rearing and holding of various salmonid species at various life stages.

Question 2: If fish, what species?

Response: Salmon

Question 3: Do you accept boxes with rotationally molded polyethylene outershell insulated with polyurethane foam instead of fibreglass?

Response: Evaluation will be based on the requirements as stated in the specifications and as shown on the drawing .

Question 4: Bidder and manufacturer have not provided aquaculture/hatchery tanks in the past to provide a reference. Will this automatically void out submittal as it is a requirement of the Mandatory Technical Criteria?

Response: Rearing tanks, as specified, are standard rearing/holding containers used at Fisheries and Oceans Canada (DFO) hatchery facilities in B.C. Only rearing tanks with a proven history of use in the aquaculture industry or at current DFO fish hatcheries will be accepted.

Question 5: Is there any type of offloading equipment at either site?

Response: There is no off-loading equipment available at either site.

Question 6: "Rearing tubs must be designed to be suitable for above ground or below ground installation". Clarification on requirements for above ground, such as legs or tank support frame, as well as what is considered below ground application.

Response: Rearing tanks, as specified, are standard rearing/holding containers used at DFO hatchery facilities. Rearing tubs, as described, are specifically designed for installation and operational use for above ground with separate support skirt system or for partially buried operations. Rearing tub installation will be determined at a later date.

Question 7: Will DFO send a Technical Authority to a Winnipeg Manitoba manufacturing facility to inspect the first tub before completing remaining order, at no cost to the successful bidder?

Response: Any inspection costs, if required, will be borne by DFO.

Question 8: Is the successful bidder required to install the tubs or assemble on site once offloaded?

Response: Rearing tanks, as specified, are standard rearing/holding containers used at DFO hatchery facilities in B.C. Assembly of the rearing tub and its components and installation for use is not within the scope of this requirement.

Question 9: Are there pictures of current or previous existing tubs for reference on requirements?

Response: No pictures are available.

All other terms and conditions of the Solicitation document remain the same.
