This solicitation amendment 002 is issued to answer question raised by the industry.

Q1 What percentage of the total evaluation is allocated to the Technical Submission?

R1 There is no percentage allocated for the technical criteria as we are not using a rated evaluation but pass/fail methodology. The offeror must meet all the mandatory technical criteria to be declared responsive. See section 4.1.1 of the RFSO.

Q2 What percentage of the total evaluation is allocated to the Financial Submission? Or is there a calculation to derive the Financial Evaluated Total?

R2 There is no percentage allocated for the financial offer as the SO will be awarded to the responsive offer with the lowest evaluated price. We will evaluate the grand total combined weighted rate for 5 years presented at the annex B of each responsive offer. See section 4.2 of the RFSO.

Q3 How will the awardee be selected?

R3 See section 4.2 of the RFSO.

Q4 We are interested in knowing the approximate total value of the Standing Offer.

R4 The estimated SO usage is \$1M, however, offerors are to be reminded that a Standing Offer is not a contract and does not commit Public Works and Government Services (PWGSC) to procure or contract for any services. Therefore, PWGSC is under no obligation to issue call-ups up to the amount \$1M.

Q5 We wish to be informed on the procedures by which qualified firms will be invited to respond to various call-ups.

R5 It is indicated at section 1.2.3 that this RFSO will result in one (1) Regional Individual Standing Offer (RISO) valid for five (5) years. See section 7A.8 for call-up procedures.
