Responses to Requests for Clarification

- Q1. Once we set our hourly rate will that rate be applied for every proposal? Or will we have to re bid the job?
- R1. Please refer to Standing Offer Particulars, SP 5 Call-up Procedure, article 1.c) & Terms and Conditions, 2000DA Calculation of Fees.
- Q2. Will we be paid extra for travel and other expenses?
- R2. Please refer to Terms and Conditions, 9998DA Terms of Payment, TP 10 Disbursements.
- Q3. I have a question regarding the security requirements. If our designers do not have the reliability level should we initiate the process now or wait until the closing date when we receive the outcome of the request for proposal?
- R3. Proponents are hereby informed that there is a strong possibility that some call-ups against the Standing Offers might require that the consultants and their personnel possesses a Facility Security Clearance (FSC) at the RELIABILITY level issued by the Canadian Industrial Security Directorate (CISD) of Public Works and Government Services Canada (PWGSC).

Successful proponent(s) issued a standing offer as a result of this RFSO, who do not possess the required security clearance at time of call up, will be bypassed and PWGSC will proceed to the next consultant who possesses the required security clearance and is furthest away from the ideal business distribution.

All other terms and conditions of the solicitation remain the same.
