1.0 Tender Document Clarifications – Bidders' Questions

- 1.1 Question: In the specs section of the project: section 07 52 16 (page 6) 3.5.3 tapered insulation, it says minimum 2% slope, and in the roof type legend in the roof plan page A300 in calls for a 1% slope, please clarify**

Response: Revise Specification Section 07 52 16, line item 3.5.3: **Delete:** "2% slope". **Insert:** "1% slope".

- 1.2 Question: Would it be possible to add the separate price item on the tender form for the reinstatement of the parapet cap as shown on drawing a200 or should we include that in the lump sum price?**

Response: Delete all references to Option 2 Separate Price. See Section 2.0 below. There will be no separate price required.

- 1.3 Question: Tender specs 075216, 2.1.8 mention use two component adhesive to install base sheet insulation panel and tapered insulation, not clear how deck sheathing want to be installed: adhesive or asphalt?**


Response: Revise Specification Section 07 52 16, line item 2.1.3 to read: "Deck sheathing: ASTM C1177, 13mm thick. Mechanically fasten or use low-rise, two-component polyurethane adhesive to install deck sheathing."

Revise Specification Section 07 52 16, line item 2.1.8: **Delete phrase:** "base sheet insulation panel".

- 1.4 Question: In specs 075216, 2.1.3 mention Deck sheathing 6mm thick but in drawing A200 says 13mm Gypsum board. Please advise the right materials.**

Response: Revise Specification Section 07 52 16, line item 2.1.3: **Delete:** "6mm". **Insert:** "13mm".

2.0 Tender Drawings – Revisions

- 2.1 Delete** Drawing Detail 5/A200.
- 2.2** Revise title of Detail 3/A200: **Delete** the words "OPTION 1".
- 2.3** Revise Roof Type Legend on Drawing A200: For Roof Type  New Roofing Assembly at Main Roof, **Delete** requirements for "13MM GYPSUM BOARD".
- 2.4** Revise Detail 3/A100: **Delete** requirements for work shown within dashed bubble for removal of existing vitreous panel parapet cap and **delete** reference to separate price.
- 2.5** Drawing A100, General Notes- Demolition, item 11: **Delete** the words "SEPARATE PRICE FORM".
- 2.6** Drawing A100 (upper right hand corner of drawing), **Delete** the words: "MAIN ROOF (SEPARATE PRICE)&" within the Note box as shown below:
