## AMENDMENT 002

The purpose of this amendment is to:  
-Advise Bidders of questions and answers;

### **Question 2**

Concerning the call for tenders, my understanding of the document is that the provider must have at least 3 instructors, which together can offer all the courses listed in Annex III (or in section 3.1 of annex A–15 different courses, in English or in French). As worded, this requirement means that only one provider is qualify to bid –some of the courses are rarely offered, and only by this particular provider. Is my understanding accurate? Can Statcan expand these assessment parameters?

### **Answer 2**

As specified in section 4.0 Language: The Contractor will deliver the courses listed in Section 3.1 in either or both official languages (English and French). StatCan will not modify the assessment parameters.

### **Question 3**

Concerning the list of courses in Annex III, if a provider must be capable to offer all the courses in V or E delivery format, again, in my opinion, only one provider is able to bid. Is my understanding accurate? Can StatCan expand these assessment parameters?

### **Answer 3**

All courses must be delivered in C (classroom) as well as in V (virtual in real time) or in E (self-pace eLearning). StatCan will not modify the assessment parameters.

### **Question 4:**

We require that 2035 (2015-09-03), General Conditions – Higher Complexity – Services be replaced by General Conditions 2010B (2010-08-16) – Professional Services (Medium Complexity).

### **Answer 4:**

Any changes to the terms and conditions of the solicitation or the resulting contract clauses are to be submitted with the bid. Statistics Canada will only consider and negotiate changes to the terms and conditions with the Bidder recommended for contract award.

### **Question 5:**

Our organization requires changes to the terms and conditions with regards to Intellectual Property and Limitation of Liability.

### **Answer 5:**
