Amendment No. 01 is raised to modify solicitation W0127-15P025 and address questions from industry as follows:

SECTION A: QUESTIONS AND ANSWERS

Q1. Does the customer want EACH gym unit to accommodate 60 users? In what time frame?

A1. Yes. The unit needs to be big enough to accommodate 60 people at varying times of the day. At no time will 60 soldiers be using it at the same time. A more realistic usage at the same time would be 20-30.

Q2. Items 1.7-1.32 is this what the customer wants EACH of the 8x mobile gyms to contain individually or is this the total for all 8 units?

A2. Yes

Q3. 1.23 What are the dimensions you require? Are these rubber mats intended for using in the workout, for instance, sit ups? Or to use as floor protection.

A3. The rubber mats need to cover the floor of the container. This will serve to protect the equipment if dropped as well as protect the floor.

Q4. 1.22 What is entailed in the bench press package? As in, what size plates and what kind of plates; bumper or steel?

A4. The bench press package should consist of the following equipment (minimum):

Bumper Plates (5, 10, 15, 20, and 25 kg)

5kg bumper x 4

10kg bumper x 6

15kg bumper x 6

20kg bumper x 6

25kg bumper x 4

Q5. Is an extension on the delivery date of March 31, 2016 possible?

A5. An extension on the delivery date is not negotiable.

Q6. I am wondering if you can clarify for me whether or not the shipping containers requested in the RFP for 8 Mobile Gyms are being used simply to store and move the equipment requested, or if the containers are actually being used as a gym facility? In addition, can you please let me know if 2 containers is equal to 1 full gym kit, or if each container should hold all of the requested equipment?

A6. The container should be self-contained and used to store and transport the equipment. The interior of the container shall be used as the gym facility for some activities, while some of the equipment can be taken out of the container and used outside. For example, medicine balls, etc. Each container should hold all of the requested equipment.

Q7. On the spec sheet you have listed "Must be deployable within 60 minutes" and I'm wondering how vital the deployment time is? The duration would change depending on the number of personnel working on setting up the equipment.

A7. 60 minutes is desirable. The idea is that the mobile gym is in fact mobile.
