Questions & Answers

Question 44 :

To clarify the issue about replacement of the rafters:

In view of there is no identification of these works (other than a text) on plans, I would like you to confirm what we can see on detail 10, A3, A5, page 5 showing a dormer's section. Does the wooden piece description "EXISTING RAFTER ± 70 X 210" the right information?

On the other hand, do these rafters to replace next to each other on the same slope, or on different slopes? What is the essence of wood? Do we have to proceed with temporary shoring to support the roof? Do the tie-beams have to be dismantle?

Answer 44 :

The information indicated on plans about dimensioning of existing rafters is accurate. The rafters to be replace are expected on the same slope but not necessarily next to each other. The wood species to use in structural members is B.C. fir (See section 06 10 11 - Carpentry). The working method is up to Contractor, so he determine whether temporary shoring is expected or not. (See Section 02 41 00 - Selective Demolition). Removal of tie-beams is not required.
