Part I General

I.1 ADDENDUM FORM

- .1 This Addendum forms part of the Contract Documents and modifies the Bidding Documents dated November 20th, 2015, with amendments and clarifications noted below.
- .2 Acknowledge receipt of this Addendum in the space provided in the Bid Form. Failure to do so may disqualify the Bidder at the Owner's discretion.
- .3 This addendum consists of one page.

I.2 CHANGES TO THE PROJECT MANUAL

- .1 SECTION 08 14 16 – Flush Wood Doors
 - .1 **Add** Item 2.1.2 Hollow core bypass sliding doors.
 - .1 2.1.2.1 Construction: Stile and rail frame with veneer panel faces, thickness 44 mm (1-3/4 inch).
 - .2 2.1.2.2 Stiles: Structural composite lumber, width 30 mm.
 - .3 2.1.2.3 Rails: Structural composite lumber, width sufficient to accommodate hanging hardware and to bear full weight of installed door panel.
 - .4 2.1.2.4 Faces: AA – premium, rotary cut birch.
 - .5 2.1.2.5 Core: Kraft corrugated paper bonded to faces.
 - .6 2.1.2.6 Blocking – Particleboard, widths as appropriate for solid attachment of door hardware.
 - .7 2.1.2.7 Adhesive: Type 2.

- .1 DRAWING A2 – Second Floor Existing/Demolition Floor Plan
 - .1 **Modify** Note #6 to read: “Remove horizontal p-lam finish on window sill. Bullnose finish to remain. Prepare substrate for new p-lam finish. The combined length of all window sills is approximately 39 m; the depth of p-lam to be replaced is approximately 275 mm.”
- .2 DRAWING A4 – Second Floor Construction Plan
 - .1 Drawing 1: Door 103 **Modify** bypass door system from two panels to three panels.
 - .2 **Add** to Keynote #8: “West elevation length of windows is approximately 12.83 m; height of windows is approximately 2.44 m.”
 - .3 **Add** to Keynote #9: “North elevation length of windows is approximately 16.2 m; height of windows is approximately 1.83 m.”
 - .4 **Add** to Keynote #9: “South elevation length of windows is approximately 13.38 m; height of windows is approximately 2.44 m.”
- .3 DRAWING T2 – Second Floor New Telecommunications Plan and General Notes
 - .1 **Clarification** General Note #9 to read: “All voice data cabling, patch panel, faceplates, and termination are to be supplied and installed by Shared Services Canada, and are not in contract.”
