The SBIPS Refresh version "K" does not seem to be available as an open solicitation in the CPSS Dashboard. When can we expect to be able to access the solicitation period in the DCC Dashboard for SBIPS?

ANSWER: The CPSS Dashboard for this solicitation will be made available at the end of February 2016.

C. Questions and Answers:

Q1: My company responded recently to the mandatory SBIPS Re-Compete EN537-05IT01/J. Are we obligated to respond to this Refresh version "K"?

A1: Suppliers will be notified of their SBIPS EN537-05IT01/J results at the end of February. At that point, Suppliers can determine whether they should respond to this optional Refresh version "K", or if they wish augment their technical qualifications (i.e. additional Streams of Expertise, Tiers of Service, Regions, etc.).
