- Q1. Section A 2.1 lists all systems on the site and buildings that will need to be assessed. Can you expand what architectural related elements are included? Does it include interior finishes and furnishings – will these be part of the review?
- A1. For system list please see AA 1.4.2
- Q2. Section A 2.2.1 Ad Hoc Study mentions that the studies will vary in scope depending on the topic. Can you provide a sample of work that is to be included in this part of the submission? Our hourly rates can greatly vary depending on the work and we would like to price this properly.
- A2. Our document describes a sample of elements which might require in-depth analysis (see A 2.2.1 for details). Any study can involve one or more disciplines. The hourly rate is fixed. The number of hours will vary based on the SOW.
- Q3. Annex F – Price Offer Page 80 of 84 – We have in-house engineers for some of the Items in Section II Sub Consultant Specialists. However, there is no room to include this information in Section I Prime Consultant. How should we included our in-house specialist team on the form as part of the Prime Consultant?
- A.3 Include them in the appropriate 'Key Sub Consultant/Specialist' section and include your firm's name on the 'Firm Name' line.
- Q4. Annex G – Team Identification Page 82 of 84 - We have in-house engineers as part of the Prime Consultant for some of the Items in Section II Sub Consultant Specialists. However, there is no room to include this information in Section I Prime Consultant. How should we complete our in-house specialist team on the form?
