Amendment 001 is raised to answer questions and to modify solicitation W0134-16R012/A as follows:

Modifications

1. Refer to Annex A, article 3.1 Mattresses:

Delete: a. Each double mattress must be the standard North American Double size of approximately 75 inches by 54 inches;
b. Each double mattress must have a height of not less than 11.5 inches and not more than 12.5 inches;
c. Each mattress must have a pillow top design;
d. Each mattress must have a fabric cover / ticking made of polyester or cotton-poly blend;
e. Color must be in the light brown spectrum. Color must coordinate or match with Item #2 offered;
f. Must have a back support system;
g. Must be non-flip design;
h. Each mattress must be an innerspring mattress with individually pocketed coil springs. Must have a minimum 800 individually pocketed coil springs; and
i. Must have a minimum 10 year industry standard warranty.

Insert: a. Each double mattress must be the standard North American Double size of approximately 75 inches by 54 inches;
b. Each double mattress must have a height of not *less than 9.0 inches and not more than 11.0 inches*;
c. Each mattress must have a fabric cover / ticking made of polyester or cotton-poly blend;
d. Color must be *white to light beige spectrum*. Color must coordinate or match with Item #2 offered;
e. Must have a back support system;
f. Must be non-flip design;
g. Each mattress must be an innerspring mattress with individually pocketed coil springs. Must have a *minimum 400 individually pocketed coil springs*; and
h. Must have a minimum 10 year industry standard warranty.

2. Refer to Annex A, article 3.3 Headboards:

Delete: a. Width (side to side) must be a minimum 59" and maximum 61";

Insert: a. Width (side to side) must be a *minimum 54" and maximum 57"*;

3. Refer to Annex A, article 3.4 Delivery, Set Up and Garbage Removal, part a. Delivery of Goods:

Delete: ii. Goods will be delivered specifically to third floor rooms of B44,

Insert: ii. Goods will be delivered specifically to *rooms on various floors* of B44,

4. Refer to Annex A, article 3.4 Delivery, Set Up and Garbage Removal, part b. Assembly/Set Up:

Delete: ii. All products are to be placed in their final placement area.

Insert: ii. All products are to be placed in their final placement area. *Placement and set-up includes attaching headboards to existing frames after removing existing headboards.*

Questions & Answers

Q1: The RFP does not stipulate a requirement for the metal bed frame which holds the foundation and allows the headboard to be attached to the frame. Is there an existing bed frame that will be used and does this frame have a headboard bracket which the headboard can be affixed to?

A1: Yes, there is a frame present with a headboard bracket which the headboard will be affixed to.

Q2: The headboard width specifies 59-61"; however, the bed width is 54" wide in a double. Is this measurement correct?

A2: Refer to Modification 2 above. The measurement has been revised to a minimum of 54" to a maximum of 57" for a double.

Q3: For set up, is the headboard to be attached to frame or wall? Or, is headboard just to be brought into barrack area on third floor?

A3: The headboard must be brought into the barrack building, onto different floors, into the individual rooms, and attached to the existing frames after removing the existing headboards.

Q4: Will the existing beds be fully set up at time of delivery? As part of set-up is it necessary to unattach the existing headboards from the frames and then remove the headboards, mattresses and foundations or will the headboards already be taken off the frames ready to be removed?

A4: The existing beds will be fully set up when delivery occurs. Placement and set-up includes disassembly of the currently bed.

Q5: Will it be necessary to unbolt the 81 headboards that require removing from premises?

A5: Yes.

All other terms and conditions remain the same
