## QUESTION AND ANSWER SERIES 2

- Q1: At Annex A, The Statement of Requirement, Section 11.2.5 indicates that the hutch doors are to be metal. Can PWGSC confirm if other materials are acceptable?
- A1: The requested metal material for the hutch doors is a mandatory requirement. Other materials are not acceptable.
- Q2: Can PWGSC indicate if the storage has freestanding furniture components or if the storage has panel hung components? There does not seem to be a difference in the description between the freestanding furniture components and the panel hung components.
- A2: Please see Attachment 1 to Annex A (Typical Layouts) and Attachment 1 to Annex B (Financial Bid Presentation Sheet) for clarification.
- Q3: Can PWGSC confirm the required quantities for WSTN-02, WSTN-04, and WSTN-07? There appears to be inconsistencies between the Typical Layouts, the Floor Plans, and the Financial Bid Presentation Sheet.
- A3: The correct quantity for WSTN-02 is three (3) one each in room 0044, 0045, 0046. There should be a quantity of two (2) for WSTN-04 in 215d and 500e. The correct quantity for WSTN-07 is one (1) in room 057. Attachment 1 to Annex B (Financial Bid Presentation Sheet), has been updated to reflect this change. Please see the amendment below.
