Amendment #1 of Solicitation 201604781 has been issued to respond to **Questions and Answers – Part 1.**

**Questions and Answers – Part 1:**

Q1 – Is any additional information available for sewer and water connection points? There is no information on the site plans as to distances to be trenched etc.

*A1 – Services are to be considered fed from the front streets in all cases.*

Q2 – Is any additional information available for Hydro connections, distance to be installed? Overhead or underground?

*A2 – Electrical services shall be overhead and fed from the front streets in all cases. Pole locations are unknown.*

Q3 – Are Geotechnical Reports available for the sites?

*A3 – No geotechnical reports are available. Contractors are to build to the requirements of the plans and specifications and advise the Project Manager of any poor soil and/or high water found.*

Q4 – Due to the amount of information that must be obtained by the proponent and the submission restrictions would consideration be given for a submission deadline extension from **February 12th** to at least **February 19th**?

*A4 – We have decided to extend the closing date to February 23<sup>rd</sup>, 2016 @ 2:00pm EST.*

Q5 – Would it be possible to bid these as Ready to Move (RTM)? There might be a cost savings.

*A5 – No, all buildings will be built in place.*
