## Description of the requirement:

The Department of Justice Canada requires the services of a contractor to conduct an evaluation of the National Anti-Drug Strategy (the Strategy), in accordance with the 2009 Treasury Board of Canada *Policy on Evaluation*. The evaluation will focus on the continued relevance, effectiveness and demonstrated efficiency and economy of the Strategy.

The Contractor must implement the evaluation plan included in the Statement of Work (Annex A) that identifies appropriate methodologies and approaches that will support the assessment of the core evaluation issues - relevance and performance of the Strategy - as outlined in the 2009 Treasury Board Secretariat *Directive on the Evaluation Function*. ## Applicable Trade Agreements:

## Security Requirement Summary:

At the bid closing date, the following security requirement (Security Requirements Check List - SRCL and related clauses) applies and form part of the Contract:

- 3. Subcontracts which contain security requirements are NOT to be awarded without the prior written permission of CISD/PWGSC.
- 4. The Contractor must comply with the provisions of the:
  - a. Security Requirements Check List and security guide, at Annex C;
  - b. Industrial Security Manual (Latest Edition).

### Proposed period of contract:

The period of the Contract is from date of Contract Award to February 28, 2017 inclusive.

The Contractor grants to Canada the irrevocable option to extend the term of the Contract by up to one (1) additional six(6) months period under the same conditions.
