Amendment No. 03 is raised to modify solicitation W0127-15P025 and address questions from industry as follows:

**SECTION A: QUESTIONS AND ANSWERS**

**Q1. Are you looking for competition or regular grade kettle bells?**

A1. Competition grade kettle bells preferred, but not mandatory

**Q2. What is the preferred length for the battle ropes?**

A2. 50 feet

**Q3. Do you want 35lb or 45lb Olympic lifting bars, or a combination of both?**

A3. 45 lb Olympic lifting bars

**Q4. Please provide clarification on the height required for the rope climbing tower?**

A4. Please remove the rope climbing tower (1) and the climbing rope (1).

**Q5. Rig Anchoring: These portable gyms/rigs, will be deployed into the field, I presume. What type of surface will they be mounted-on? As cement anchoring will obviously be different than grass or sand anchoring, but regardless of the surface, these types of set-up need to be safely anchor, is this at the users' discretion and vendors do not need to provide anchoring hardware?**

A5. This item will primarily be used in the field on grass/compacted ground and while in Garrison on a concrete pad. It is up to the supplier to determine if anchoring is required.

**Q6. Packaging: Will fork-lifts be used to unload the portable gyms/rigs or will it be done manually? This will have an impact on the packaging of the equipment, shipped via containers.**

A6. Will be moved with a forklift or a military sea can vehicle type vehicle (PLS- Pallet Loading System) that has a connection to clamp and then pull a standard sea can up and onto the vehicle chassis for movement.

**Q7. Bench Packages: Can we clarify what exactly is required; actual bench press + barbell and 230lbs weights? (Is it, including the barbell, or not?)**

A7. Bench- The bench must be of an Olympic nature and be very robust to handle the heavy weights and barbells included in Annex A - statement of work (refer to Amendment No. 001)

- Q8. The 10x8x8.5 Containers/Transport Cases: Do they need to be brand new containers/transport cases, or can used containers, meeting all specs/requirements, be admissible?**
- A8. Containers and equipment must be new
- Q9. Annex A - 1.9 medicine balls - There is a requirement of 5 medicine balls but the weight is listed for only 4.**
- A9. The last medicine ball should be 11.34kg or 25lbs
- Q10. Annex A - General - For any items listed in kilograms (kg), Could those items be substituted with equivalent pounds (lbs)**
- A10. Yes
- Q11. You state in Items 1.8 that the product must include 12 pull-up stations. However, you do not clarify that this item, which are part of the external training Rig, must be mounted and attached to the actual shipping container. Can you clarify that this is the requirement?**
- A11. Part of the question 1, this item (Pull-up station) will need to have the capability to be secured (but removable for shipping, so non-permanent) on the exterior of the shipping container for use.
- Q12. This type of equipment is intended to be used outside in all weather, but your requirement did not clarify the correct treatment of the steel to ensure it is all weather. Please confirm that hot-dip galvanization and powder coating of the external functional training rig are a requirement.**
- A12. The container must be an all-weather container, able to withstand the elements and resistant to corrosion. It is up to the supplier to determine how they will meet this requirement.
- Q13. 10ft containers are not the commercial cargo standard, therefore would item 1.2 still apply?**
- A13. Yes, we utilize 10 ft seacans "tri-cans" commercial cargo standard for shipping purposes regularly within the Canadian Armed Forces. We have Canadian Forces Cargo Unit numbered containers that are deemed sea, air and road worthy.
- Q.14 When will the contract be awarded?**
- A14. An estimated award date will be two weeks from the solicitation closing date, subject to any additional verifications required by Canada on bids received.
- Q15. 4 - Can you confirm if the 10ft container will be ship/move around as a "Sailway Commercial Standard" or will it be transported exclusively by the Army carriers?**
- A15. This unit will be transported by military carriers, but this not exclude the requirement to be road, air and sea worthy.
