3. QUESTIONS AND ANSWERS

Question 1. Can you please provide a list of attendees to the site visit?

Answer 1. Due to privacy issues this information cannot be provided.

Question 2. Drawing provided only show Building 1, 2, 3, 4 and A1, on Page 5 of 7 The Specification describes building 1, 2, 3, 4, 19 please confirm which numbering scheme?

Answer 2. Building 1,2,3,4 and A-1 is correct. Any reference to building 19 shall be removed from the plans and specifications.

Question 3. KSI key system is not an integration partner with Best Access or RBH? Could we select an integration partner on the KSI site?

Answer 3. There is BEST Access Systems components currently installed within the institution. We have confirmed with KSI that BEST will integrate with the KSI System. Best Access must be maintained.

Question 4. Where are the card access panels to be located in building 2, 3, 4 and A1?

Answer 4. Card access panels are located in Building 1 in the Central Communications/Equipment Room and in building 3 only. All other readers and keypads tie into the Key System Directly.

Question 5. Section 28 13 00, page 5, 2.4.21 indicates 7 cabinets in Building 3 and 1 cabinets in Building 19. Drawing E-5 indicates 8 cabinets in Building 3 and 0 cabinets in Building 19. Please confirm what is required?

Answer 5. The answer to this question is part of this amendment. See part 2 SPECIFICATIONS.

Question 6. Request extension to Solicitation Closing Date?

Answer 6. NO extension to Solicitation Closing Date. Closing Date remains as originally posted.
