There is no guarantee that any quantity of any of the business card types will be ordered in any resulting call-up. Offerors must base the pricing on the supply of one (1) box at a time.

Question 10:

We have received the Excel grid. It is indicated "**Quantity for Evaluation**".
Did you mean : Number of lots - ex: Quantity for Evaluation (850) - Is 850 lots of 200 cards.

Response 10:

Yes. For example, Business card (Type A) and business card (Type B): The price per box of 200 cards (lot price) will be multiplied by the quantity for evaluation, added together, and then divided to obtain the average price (as specified in Annex "B").

Quantities for evaluation shown in the Annex "B" BASIS OF PAYMENT are estimates for evaluation purposes only and are not a guarantee of an actual number of business cards to be produced, nor are they intended to reflect any expectations on behalf of the Government of Canada.
