AMENDMENT 001 QUESTIONS FROM POTENTIAL BIDDERS

Question & Answer

Q1. 6(b) 2(a) "Sew on Canada" on NCD dress and 6(b) 2(b) "Sew on rank badge – 2 per jacket" on NCD dress – I believe these items are no longer sewn onto NCD garments.

A1. Name Tags and unit Crest are still sewn on jackets.

Q2. 6(e) 1, 2, and 3 "Removal of Badges" – this work is normally deemed to be included in the prices for sewing on the badges, and not a separate item. Only removing Officer Braid without being replaced might be an item, but is very rare.

A2. Depending on posting, or deployments, London does remove badges without replacing them.

Q3. 7(a) – "Sew Slip-on closed each" - are they referring to "each individual slip-on" or to "each pair"?

A3. Each

Q4. 8(a)1 "Construct CF Ribbons – Single Ribbon/Bar" and 8(a)2 "Two or More in a set Ribbon/Bar" – these are usually no longer manufactured as they are given out through the CF Supply system.

A4. London does a lot of their own ribbons due to lack of stock through the Supply System

Q5. Annex A, Statement of Work, Tailoring Services

#4 "Conditions" (as relating to on-site tailoring service hours) – Would CFB London consider a pick-up/drop-off plus measuring services/clients services only one full day a week vice a daily on-site tailor?

A5. No Daily on-site tailor is required.

Q6. "Services as Required Consisting of the Following" 1(a) – False Hems- these should be a separate item as these require much more work than just a straight-forward raising/lowering hems for both jacket sleeves and pant-legs.

A6. Will stay as 1 item.
