Questions and Answers – Part 3:

- Q21 Instead of doing proposed 8" concrete wall with a framed wall with r20 on the inside, can we do a ICF basement wall which gives you a r22 foundation and eliminates the 2x4 wall on the inside?
- A21 Yes.
- Q22 What percentage is required for Labour and Material Bonds? Do you require a letter of intent in addition to the actual Tender Documents?
- A22 A minimum of 50% of the resulting Contract is required for Labour and Material Bonds. The request to submit this bond only occurs after a successful Contractor has been identified.
- Q23 Are any window coverings required for this project or will this be done through the owner?
