Q1. Correction to Amendment No. 007, Rated Criteria – A.5 ERP Technical Analyst (CRM), Level 3 (Core), R1.

A1. Canada still accepts MCTS certifications from 2015 as well 2011 and 2013 for R1. Please see RFP modifications #008.

Q2. Bidder Mandatory Corporate Criterion M1 (across all streams) requests that the Bidder have experience within a GoC Department or Agency, Crown Corporation or Provincial/Territorial Government department or Agency. Given that our firm's Client Representative and all of its proposed resources have the requisite public sector experience, would Correctional Service Canada consider amending the Bidder Mandatory M1 across the streams to also include private sector experience?

A2. No, Canada is not prepared to revise these corporate criteria.
