This solicitation amendment number one (01) is issued to provide information discussed during optional site visit, conducted on February 3.

Questions & Answers:

1. What is the flooring in the Den made of?

Answer: The flooring in the Den is Marmoleum Real.

2. What do you do about bears?

Answer: In the spring, Parks Canada Resource Conservation Officers offer a Wildlife Safety session that contractors are invited to attend.

3. If there is rodent excrement does the entire floor need to be bleached?

Answer: No, contract staff are expected to follow proper procedures for cleaning mouse droppings. This would fall in the RFP under Pg. 25, 1.0 Safety, where Contractor is expected to 1.2 "Perform work in accordance with the rules and regulations of the Canada Labour Code and the Worker's Compensation Board."

Correction to Answer:

When asked about who maintains the water system in the basement of the Bunkhouse it was answered incorrectly by our staff. As per the RFP page 29 ' weekly checking of the water softening system is required, and salt added once / week or as needed' is the responsibility of the Housekeeping contractor.

Changes to the Statement of Work:

Amendment to the Contract: The Lodge should be removed from the Contract, because it will remain closed for the duration of the contract. Background: The Lodge was included in the RFP on page 16 "Lodge may be included in the term of the Contract but the building is currently closed to public use'. It was discussed that due to structural issues and the timeframe of possible funding the Lodge will likely not come into inventory or opened to the public with in the next 3 years. It should not be factored onto the bid.

Remove the following from Annex A – Statement of Work

- Lodge may be included in the term of the Contract but the building is currently closed to public use

All other Terms and Conditions remain unchanged
