QUESTIONS AND ANSWERS

QUESTION 011:

As an existing supplier our company would like to add an additional stream but only one classification in Stream 5 Professional Services. The solicitation states:

“The supplier may provide up to a maximum of 40 temporary help resource names and may provide up to a maximum of 4 temporary help resource names in each sub-stream. The supplier must provide a minimum of 20 different temporary help resource names and a minimum of 2 different temporary help resource names in the sub-stream that are compliant.

The supplier may repeat any of the 20 compliant temporary help resource names in any of the sub-streams to demonstrate the 2 temporary help resource names in each sub-stream.”

Does this mean I can reuse the 20 names provided to qualify us for Stream 4 and then only an additional 2 names that are specific to Professional Services? Do I have to provide the 20 names again under stream 5 in the RFSA Technical Response Template plus the additional two names that are specific to the Classification or do I only need to provide the additional 2 names to qualify?

ANSWER 011:

As per the Mandatory Evaluation Criteria, Attachment 1 to Part 4, the supplier must identify in its arrangement the classifications, streams or sub-streams it wishes to offer using the applicable Technical Response Template. As part of the mandatory criteria M2C for Stream 5, the supplier must provide a minimum of 20 different temporary help resource names that are compliant, and a minimum of 2 different temporary help resource names for each sub-stream that are compliant. The 20 compliant temporary help resource names and the 2 compliant temporary help resource names for each sub-stream can be the same names as provided for M2A or M2B or both criteria.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
