Q1: How many helicopters are being requested? Is it 6?

A1: There is a potential of 3 aircraft at once. Refer to:

Section 00 21 13, 1.10 .1.1 sub paragraph .2 and .5 pertain to 1 helicopter

Section 00 21 13, 1.10 .1 sub paragraph .3 and .4 pertain to 1 helicopter for firefighting

Section 00 21 13, 1.10.1 sub paragraph .6 pertain to passenger transportation

Q2: I read an estimate of 67 hours per year. Is that correct?

A2: Yes. Section 00 21 13, 1.10 Measurement for Payment .2 Quantities may increase or decrease and are to be used as a guide line only.

Q3: Is the mobilization and demobilization paid?

A3: No, Mobilization of equipment to and from the base will be at the Contractors expense.

Q4: Must the aircraft remain in New Brunswick for the duration of the contract?

A4: No, only for duration of each call-up.
