Amendment #4 of Solicitation 201604781 has been issued to respond to **Questions and** Answers – Part 4, and <u>Request for Alternative Products and/or Materials – Part 3</u>.

# **Questions and Answers – Part 4:**

- Q29 The requirement is for 1 1/2" rigid insulation on all exterior walls; however, only Hardi Board siding can be installed for rigid insulation over 1". Please clarify.
- A29 The 1.5" rigid insulation has vertical 1.5 inch strapping every 2 feet; approximately.
  The Hardi Board siding can be fastened solidly on the strapping through the air and water house wrap which is fastened right to the OSB sheathing and structural framing.
- Q30 Is Air Conditioning included in this requirement?
- A30 No.
- Q31 Do the exterior doors get storm doors as well?
- A31 Yes. See Specification 08A (3).
- Q32 Do exterior doors get windows in the slab?
- A32 Yes. See Specification 08A (3).
- Q33 In Coronach specifically, there is only 1 sewer and water service into lots 2 and 3. Is it acceptable to service both sides off the duplex off of one 4" sewer line and 1 3/4" water line?

**Note:** I've confirmed with the town of coronach that they will accept this. There would still be a water meter for each side. The only other option to have two separate waterlines is digging up the newly paved street and tying a new service into the main. The town will not cover any of these costs.

# A33 – In Coronach, feed the building with one 4 inch sewer line and one 1.75 inch waterline, both units are to be separately metered.

Q34 – In Coronach, it appears that the yard of the existing RCMP single family dwelling to the south encroaches into lots 2 and 3 of the duplex by approximately 15'. Fencing and a garden shed will need to be relocated. Should the tender include costs involved in relocating the shed and demo of fence?

# A34 – No, do not include this. This matter will be handled separately.



- Q35 Do we leave the bid amount blank for the project locations we are not interested in bidding?
- A35 Yes, you can leave them blank, or enter "n/a".

# **Request for Alternative Products and/or Materials – Part 3:**

- Request 6 Justin Iversen DSI Contracting Bakor Dampproofing Concrete Foundation, Taymor Door Hardware, and River Rock.
- Response 6 Bakor dampproofing is not approved, as no brush or spray on products is allowed. Taymor Door Hardware is not approved for security / consistency reasons. 0.75 Crused rock (clean) would be approved, only where River Rock is not available.
