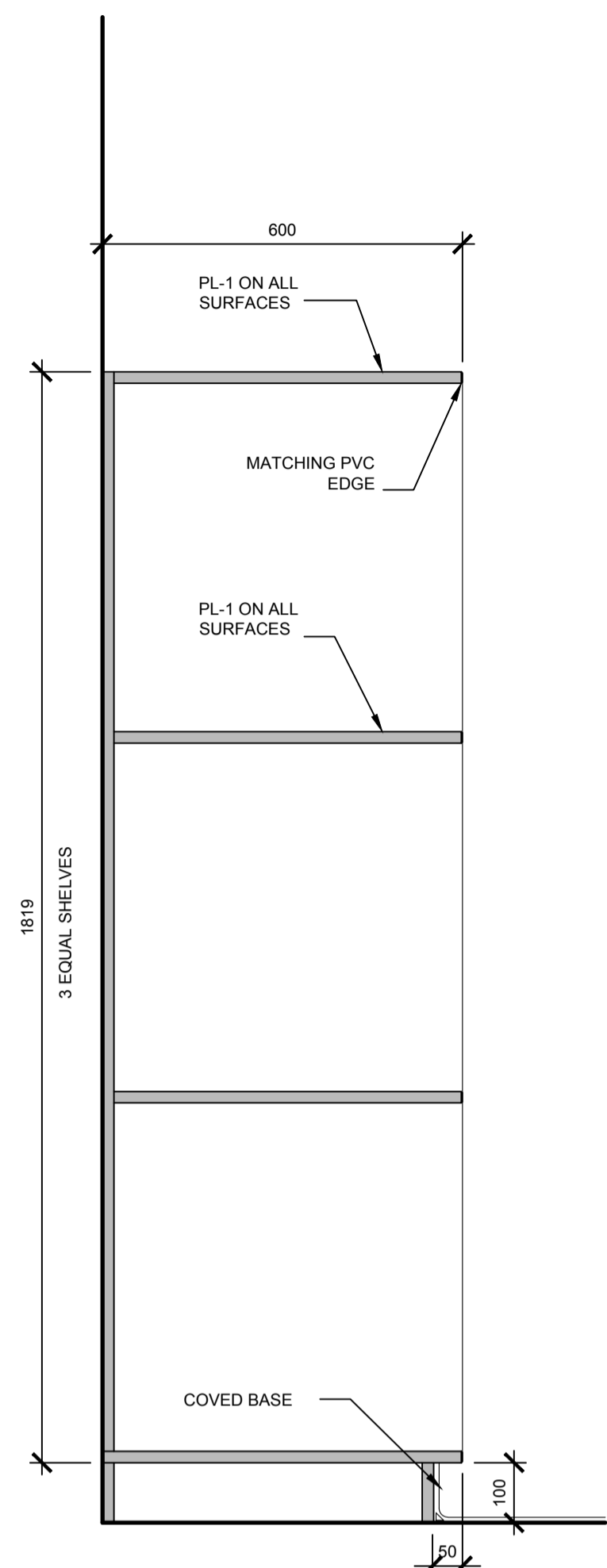


ISOMETRIC OF B10, B11, & B12

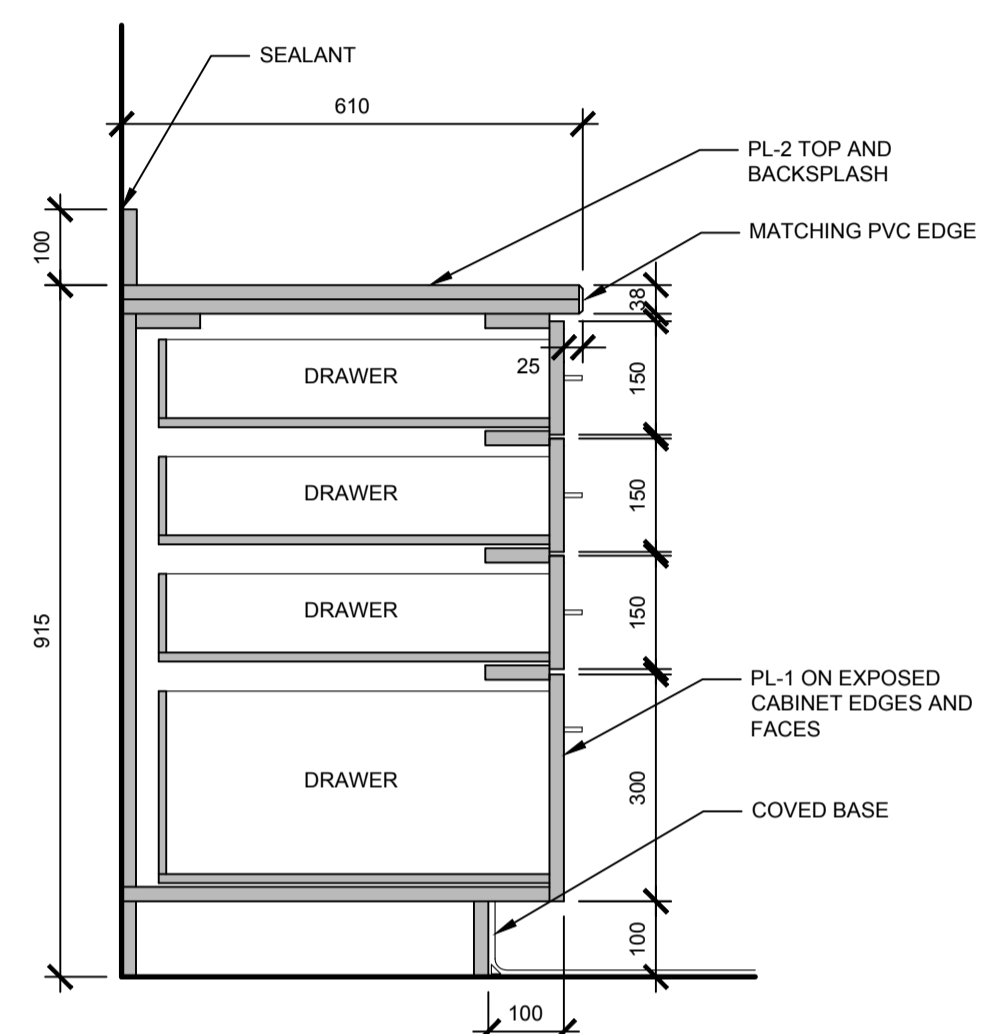
