

Questions & Answers

## Q1. Is there currently, or has t

1here been within the last 6 months, a contractor performing these functions? If so, what company is performing these services, how long has it been in place, and what is the contract value?

A1. Yes there is a contract in place. The contract is with TPG @\$6,941,686.00 from July 2014 to present.

Q2. For the level 3 role, R3 scoring currently states 5 points for 5 years, 7 points for 5-7 years and 10 points for over 7 years. The scoring rubric for all other rated requirements allows for maximum points for 4+ years of experience. It's unclear as to why the scoring is changed and increased to over 7 years of experience for R3. We respectfully request that the Crown amend the R3 scoring to 5 points for 5 years, 7 points for 5-6 years and 10 points for over 6 years of experience to increase the pool of qualified candidates.

A2. The level of scoring remains the same.

Q3. . For both the level 2 and level 3 positions, the scoring for R6 allows for 1 point per project up to a maximum of 10 points or 10 projects. Many highly skilled consultants have worked on large, multi-year, complex projects that integrate with other systems. We request that multi-year projects be assigned a project equivalency e.g. each 12 month project period would be equal to 1 project to account for Consultants who have worked on long-term development projects, from inception to delivery (full lifecycle). Several competitive RFP's have made this provision and it would be excessively restrictive and not in the interest of the Crown to disqualify otherwise highly skilled resources. Please confirm that for any additional increments of 12 months, the Crown will consider this another 'project' for the purposes of evaluation, similar to other recent and relevant TBIPS RFPs with this type of project duration definition. Also to more fairly evaluate resources who have longer duration spans of experience.

A3. Points rating will be changed as below: Please see Revision-01 of the RFP for details

- A project cannot be less than a 12 months period.
- Multiple projects in a 12 month period will equal 1 point

Q4. R2/Lv2 & 3 states "The proposed resource should clearly demonstrate minimum of 2 years' experience installing, configuring and supporting Oracle Weblogic and/or Ariba's Synergy and/or Atlassian's Confluence Wiki and/or others." Can you please confirm what alternatives would also be considered.
