Section 1: Questions and Answers (Set 9)

Note: Questions are numerically sequenced upon arrival at PWGSC. A question and its answer will be provided via BuyandSell as the response becomes available. Potential bidders are therefore advised that questions and answers may be issued via BuyandSell out of sequence. The following questions have been received. In accordance with Article 13 under 2003 Standard Instructions - Goods or Services - Competitive Requirements (2015-07-03) which has been incorporated into the RFP in accordance with Article 2.1 of Part 2 of the RFP, the questions and corresponding answers are provided to all potential bidders as set out below:

- Q69. In light of the how significantly the most recent amendment restructures the RFP we respectfully request a **10 day extension from the closing of February 22, 2016 to March 3, 2016** allow bidders to adjust their responses.
- A69. Canada has considered the request. The bid closing date has been extended to February 29, 2016.
- Q70. Given the amount of revisions to Attachment A – Technical Evaluation Criteria and the complexity of the linkages of the mandatory and rated requirements, vendors now have to completely change their response and potential contracts. The complexity of these changes in fact create a whole new approach and new RFP response. We are therefore requesting a 2-week extension to the current closing date (February 22, 2016) to allow vendors the appropriate amount of time to respond to these changes and foster a competitive process for the Crown.
- A70. Please see response A69.
- Q71. In response to amendment 10, there are 6 documented requests for extension with 4 Bidders specifying a date a February 26th. The amount of requests to extend the solicitation close date provides the Crown with the magnitude of the changes made in Amendment 8. The Crown needs to understand that many firms were in a state of non-compliance prior to Amendment 8 and were therefore not utilizing resources to produce a proposal. Amendment 8 introduces new requirements making it a new Request for Proposal. The original RFP was released on December 10, 2015 with a 42 calendar day term closing on January 21st, 2016. To ensure a fair and transparent procurement process we are requesting that the Crown extends this solicitation to March 15th, 2016 which is a 42 calendar day term from February 3rd, 2016.
