This amendment #001 was raised to address a question received in relation to this solicitation.

**Question 1:**

On page 59 of the RFSO for Solicitation No. EZ899-161629/A -DISO Hwy & Bridge Proj. Consulting, under Section 3.3 Summary Description of Required Services; 3.3.1.1 Engineering Services; one of the services required includes "Forensic Engineering" – can you please clarify what the anticipated scope of services would be required for "Forensic Engineering"?

**Answer 1:**

In general the definition of Forensic Engineering is the investigation of materials, products, structures or components that fail or do not operate or function. Generally, the purpose of a Forensic Engineering investigation is to locate cause or causes of failure with a view to improve performance or life of a component, or to assist a court in determining the facts of an accident.

We do not anticipate much need for such services, but sometimes unexpected failures/accidents do happen to transportation infrastructure. Scope of services required will/would be tailored to the type of structure/material that failed and the intended function of the structure/material.
