AMENDMENT 002

REQUEST FOR STANDING OFFER LANDSCAPE ARCHITECTURE – VARIOUS SERVICES, QUEBEC AREA

The objective of amendment 002 is to:

- Provide questions and answers about the request for standing offer (RFSO); and
- Modify the call up limitation for each call-up against the Standing Offer.

Apply the following amendments to the request for standing offer:

1) QUESTIONS AND ANSWERS

Question 1

In article 4 of the request for standing offer dealing with issues and disciplines covered by the standing offer, it is indicated that the mandate must integrate resources required in various areas of urban parks or natural parks such as ecological design: development of ecosystems. The resource requested in article 3.3.4 to cover this area (skills and experience of staff) must be a landscape architect conservation specialist, member of the AAPQ and have 10 years of service delivery including the design and development of phytotechnology components and ecological sites in urban areas.

Is a professional (member of a professional corporation) of another related discipline to ecology such as a biologist, forest engineer or agronomist and with more than 10 years of experience in design and development of phytotechnology components and ecological sites in urban areas, (wildlife habitat, wetland creation, storm water management, rehabilitation of industrial land, slopes, trail design, banks, etc.) may be presented as equivalent to the resource in landscape architecture for this aspect?

Answer 1

A biologist with 10 years of service delivery for the implementation of plans and specifications for the execution involving the design of phytotechnology components and development of ecological sites in urban areas may be accepted. It is understood that an example of Phytotechnology (vegetated roof, vertical vegetation structure, vegetated system, storm water management, phytoremediation techniques, stabilization work for slopes and banks) and by ecological development of sites (location selection and organization, measures to minimize site disruptions, erosion control, water efficient landscaping, water systems management on the site, heat island control, light pollution)
